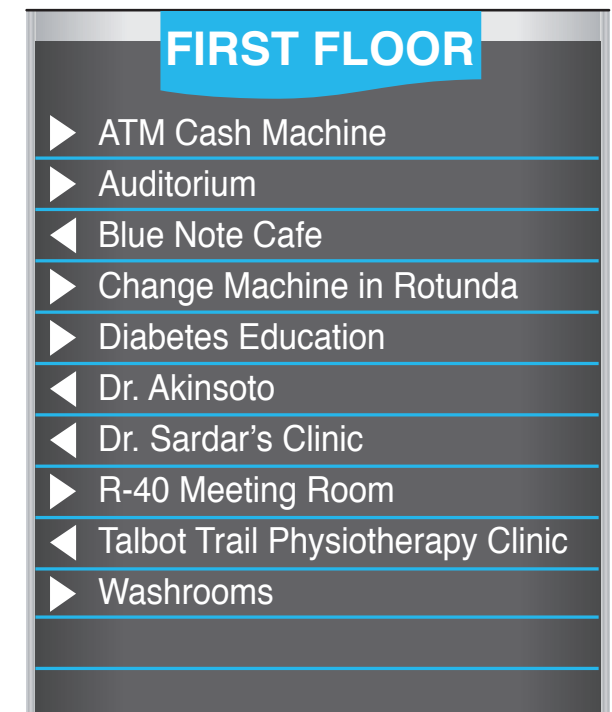

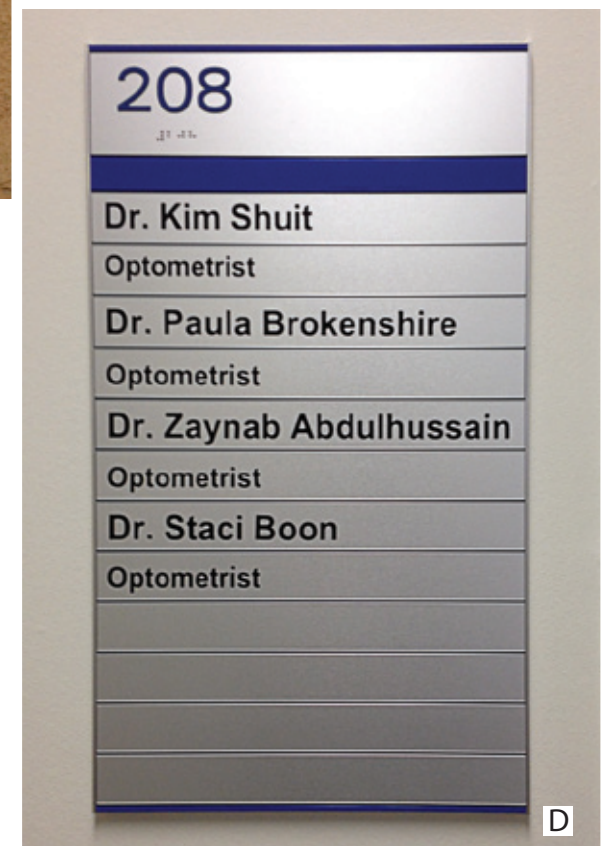
Design 2- Directory on PVC Option 1 B



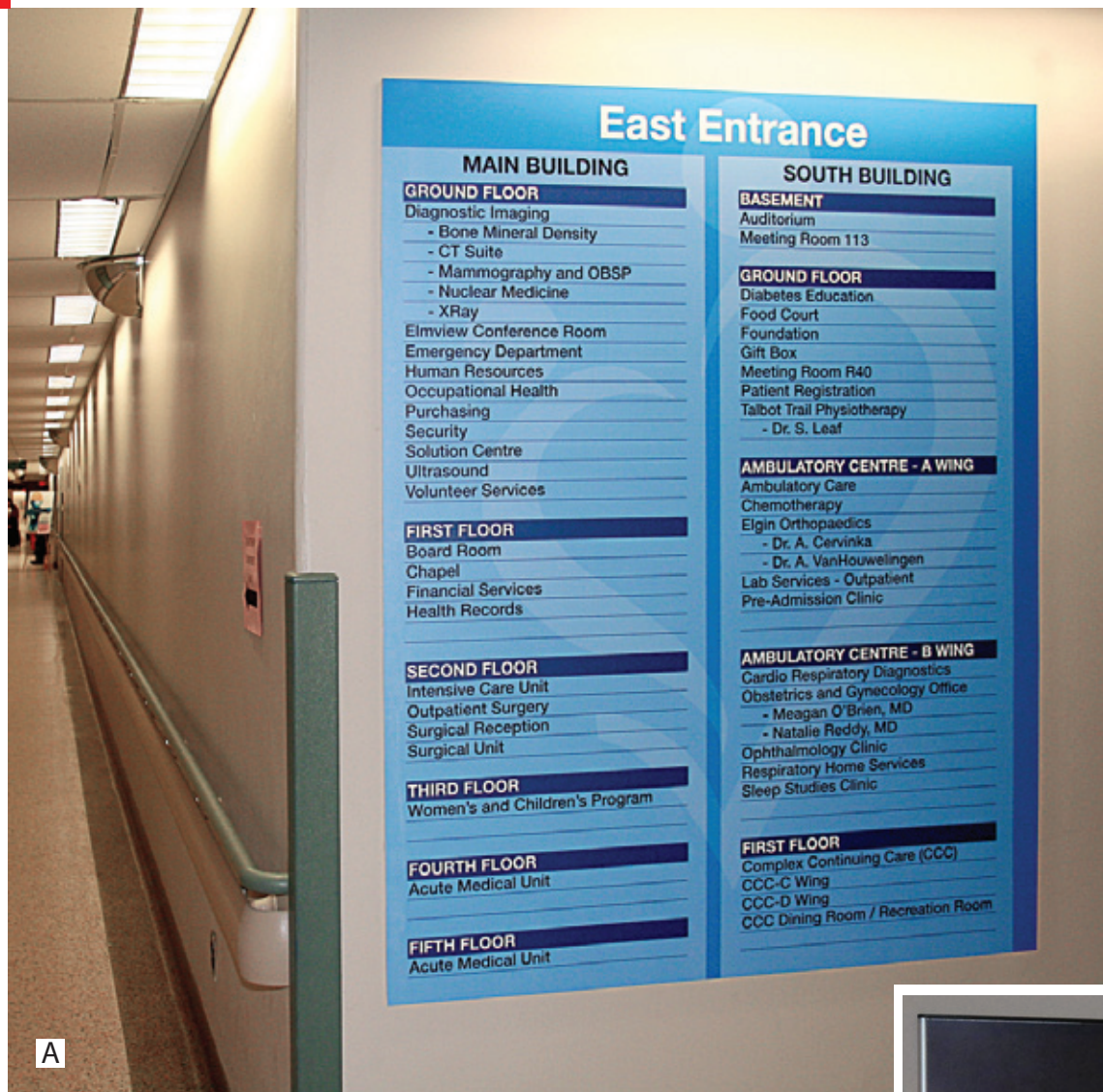
